SPEECH REFERENCE

I look back to find that there are so many people to thank: firstly, my wife, Madhubala who has tirelessly worked towards the needs of the family and children and never made any grievance of my absence to contribute to the family time due to work callings. On this occasion I would like to thank my parents for their unequivocal love and support for me and for having been my personal source of strength. I thank my daughter, Nupur and son, Nitesh for their unparallel love and care. I would also like to thank the Hon'ble Chief Justice for always treating me with kindness and affection. I am also deeply indebted to many of my predecessors and doyens of the Indian Judiciary, who served as guiding sources to me throughout. I also express my profound thanks to my sister and brother judges of this Court who have gladly put up with me. I am further grateful to the Protocol Branch who have been rendering all possible assistance to me even at odd hours. Last but not the least; I am indebted to my staff for their unstinted support and unalloyed loyalty who were tolerant enough to bear the brunt of my anger at times.

I cheerfully take leave of you; I carry no grouse, no ill-will towards anyone. I seek forgiveness for my faults. I go with only fond memories, a heart brimming with happiness and with a deep sense of gratitude to this court, which gave me an opportunity to serve!
