**NOTE:**

1. In view of the Note inserted in Corrigendum issued on 17.01.2020, the candidates belonging to ST category have not been given any relaxation in marks on account of being an ST Category candidate. However, such candidates being eligible to compete against the General vacancies, have been governed by the criteria applicable to the candidates of General Category in order to be shortlisted for the Mains Examination.

2. Delhi Higher Judicial Service Main Examination (Written) - 2019 will be held on 14th and 15th March, 2020 and it would consist of four papers viz (1) General Knowledge and Language, (2) Law - I, (3) Law - II & (4) Law - III.
