6.	Installation charges


The quotations to be submitted by the authorized vendor(s) only and must be accompanied by Demand draft/Pay order of 5% of total amount in favour of "The Registrar General, Delhi High Court, New Delhi-110503" towards earnest money deposit (refundable without interest on written request). Quotation submitted without EMD shall be summarily rejected.

The authorized vendors are requested to submit the necessary quotations strictly as per Annexure-'A', in a sealed envelope to the AO(J)/I.T & Stationery Branch, Lawyers' Chamber Block-III, Delhi High Court on or before 26-03-2019 clearly mentioning the features/configurations of the product offered. The envelope should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject of this letter be superscribed on the envelope. No quotations shall be entertained after due date. Envelopes without subject shall be summarily rejected.

The DD/Pay order towards EMD of all the tenderers, except the lowest three, shall be returned against receipt. If the offer of quotation withdrawn by the tenderer after opening of tender or any other default, the amount of EMD will be forfeited.

The final rates offered for the above items should be inclusive of all taxes and the taxes applicable should be clearly and separately mentioned. The selected vendor will have to submit current authorization letter from OEM. The warranty period should also be clearly mentioned. The validity of rates should not be less than six months from the last date of submission of quotation. Quotation with less period of validity of rates shall be rejected.

This Court reserves the right to modify/amend the quotation letter/terms and conditions at a later stage.
