
Note : Any higher specification would also be considered but not the lower one.

Quotations with less period of validity of rates shall be rejected.

The envelope should be addressed in the name of "Registrar General, Delhi High Court, New Delhi" and the subject of this letter be superscribed on the envelope. No quotations shall be entertained after due date. Envelopes without subject & Compliance Report shall be summarily rejected.
