1. Apple ipad Pro 11 inch having latest generation processor – (wifi + cellular - 128 GB, 256 GB and 512 GB options) with Apple Pencil and Magic keyboard.
2. Apple ipad Pro 12.9 inch having latest generation processor – (wifi + cellular - 128 GB, 256 GB and 512 GB options) with Apple Pencil and Magic keyboard.
3. Samsung Galaxy Tab S-6 LTE with keyboard.
4. Microsoft Surface Pro 6 KJU series (8th Gen i7 processor/256 GB SSD/8 GB RAM) with magnetic keyboard and pen.

The authorized vendors are requested to submit the necessary quotation(s) alongwith the copy of current authorization letter of the OEM and Earnest Money Deposit (EMD) worth Rs. 10,000/- by way of Demand Draft or bankers Cheque drawn in favour of "The Registrar General, Delhi High Court" payable at New Delhi. Vendor(s) offering multiple model of iPads/Tablets will have to submit authorization letters from different manufacturer(s). Quotation without EMD shall be summarily rejected and no request for waiver will be entertained.

Sealed envelope containing quotation & EMD must reach to the AOJ (IT & Stationery Branch), Lawyers' Chamber Block-III, Room No. 6, Ground Floor, Delhi High Court on or before 15-07-2020 till 5:00 P.M. clearly mentioning the Model Number/features/configuration of the product being offered. **The validity of rates should not be less than 180 days from the last date of submission of quotation and taxes applicable should be clearly mentioned. Quotations with less period of validity of rates shall be summarily rejected.**

The envelope should be addressed in the name of "The Registrar General, Delhi High Court, New Delhi" and the subject "**Quotation for iPads/Tablets along with EMD for IT/Sty. Branch**" should be superscribed on the envelope. No quotations shall be entertained **after due date**. Envelope(s) **without subject** shall be summarily rejected.
