ORDER

Hon'ble the Chief Justice of this Court has been pleased to confer the following powers on Mr. O.P. Saini, District & Sessions Judge-cum-Special Judge (PC Act)(CBI), Rouse Avenue Court Complex or any other officer posted as such, and in his absence, the next senior most available officer posted at the Rouse Avenue Court Complex :

- (i) To transfer cases amongst the courts functioning at Rouse Avenue Court Complex in order to rationalize the work in the courts functioning at the said court complex and/or any other exigency[ies] of work; and
- (ii) To act as Head of Department of the Rouse Avenue Court Complex, DDU Marg, New Delhi.

Notes:

1. The officers posted at the Rouse Avenue Court Complex shall be under the administrative control of the District & Sessions Judge-cum-Special Judge (PC Act)(CBI), Rouse Avenue Court Complex, DDU Marg, New Delhi.
