15. The District & Sessions Judge, North-West, Rohini shall assign the cases of the Court of ASJ (FTC), North-West, Rohini (abolished) and District & Sessions Judge, West, THC shall assign the cases of the Court of ASJ (FTC), West, THC (abolished) to the other Courts of similar jurisdiction of their respective Districts, to ensure equitable distribution of cases. The District & Sessions Judge, North-West, Rohini shall assign the cases under NDPS Act of the Court of Special Judge, (NDPS) North-West, Rohini (abolished) to the Court of ASJ-02, North-West, Rohini [henceforth ASJ-02-cum-Special Judge (NDPS), North-West, Rohini] and the remaining cases of the said Court to the other Courts of similar jurisdiction of the said District to ensure equitable distribution of cases. The District & Sessions Judge, East, KKD shall assign the cases under Electricity Act of the Court of ASJ (Electricity), East, KKD (abolished) to the Court of ASJ-05, East, KKD [henceforth ASJ-05-cum-ASJ (Electricity), East, KKD] and remaining cases of the said Court to the other Courts of similar jurisdiction in the said District to ensure equitable distribution of cases. The District & Sessions Judge, South, Saket shall assign the cases of the Court of ADJ-05, South, Saket (abolished) to the other such Courts of the said District to ensure equitable distribution of cases.
