**Subject: Provisional Lists for the forthcoming DHCBA Election-2022**

Sir,

In compliance of the order dated 02.06.2022 passed by Hon'ble High Court of Delhi in Writ Petition (Civil) No. 8197/2022 with respect to Delhi High Court Bar Association (DHCBA) Election-2022, the Election Committee duly undertook the task assigned to it and scrutinized the declaration forms received from the members by the erstwhile Scrutiny Committee and in furtherance of the same, this Committee has drawn the following lists:-

(a) **List A** : Consolidated provisional list of eligible and ineligible Advocate/voters of the DHCBA. (140 pages)

(b) **List B** : List of Advocates provisionally found to be ineligible due to having filed declaration in elections to other Bar Associations. (13 pages)

---

(c) **List C** : List of Advocates provisionally found to be ineligible as Bar Council Enrollment number mentioned in declaration form is found matching with Enrollment number of other Advocates whose name are appearing in the voter list in the other Bar Associations. (03 pages)

---

(d) **List D** : List of Advocates provisionally found to be ineligible as more than one declaration forms have been received with the same name and Bar Council Enrollment number. (07 pages)

---

(e) **List E** : List of Advocates provisionally found to be ineligible as more than one declaration forms have been received with same Bar Council Enrollment number but with different names. (01 page)

---

(f) **List F** : List of Advocates provisionally found to be ineligible having not cleared AIBE, according to data received from Bar Council of Delhi. (03 pages)

---

(g) **List G** : List of advocates provisionally found to be ineligible as they are either not members of DHCBA or have given incorrect / nil particulars of their DHCBA Membership details in declaration forms or their forms are not traceable. (01 page)

---

The Committee is of the unanimous view that objections are to be invited from Advocates provisionally found to be ineligible to be included in the final list of voters of the DHCBA.


Such objections may be filed with the DHCBA by 05.00 PM of 22.08.2022 failing which it shall be presumed that the Advocates who have filed their declarations have nothing further to say.

The DHCBA to transmit all objections received till 05.00 PM of 22.08.2022 to this Committee by 23.08.2022 including giving the current status of clearance of DHCBA dues and the cut off date for eligibility with respect to associate members.


You are requested to forthwith display the lists at prominent places within the Delhi High Court premises including uploading on your website, for the information of the members.
