3. The courts of MM (NI Act)-6 and MM (NI Act)-7, Dwarka hitherto presided over by Mr. Gopal Singh Chauhan and Mr. Ravinder Singh, respectively, stands redesignated as MM (NI Act)-2 and MM (NI Act)-4, respectively.
4. The District & Sessions Judge (HQ), Central, 'THC' shall assign sufficient number of cases to the newly created Court of Mr. Apoorv Sarvaria, Civil Judge-14, Central, THC on withdrawal from other such Courts so as to ensure equal pendency.
