The reserve price of ₹ 3.60 lakhs was fixed for the goods in question. However, this reserve price is not met as no bids have been received. On an earlier occasion, on 12.11.2013, one bid had been received for an amount of ₹ 2.25 lakhs. As the said bid was less than the reserve price the same could not be accepted.

The learned counsel for the Official Liquidator informs that the goods in question are in a dismal state.

I consider it appropriate that the reserve price be reduced to the extent of 25% and bids be invited by hands bills and information on the website of Ministry of Corporate Affairs in Delhi, website of Official Liquidator in Mumbai and Delhi and on the website of the High Court of Delhi.
