**Notes: -**

1. Mentioning of urgent matters before DB-II.
2. Matters other than part-heard, presently pending before various Benches shall stand transferred to the respective Benches as per the above roster.
3. Specially directed matters may be assigned by Hon'ble the Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or in specially constituted Benches.
4. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
5. Matters pertaining to unauthorised construction being heard by the Division Bench headed by Hon'ble Mr. Justice Vikramajit Sen shall continue to be heard by the same Bench.
6. Civil Writ Petitions (Service & Labour) of the year 2011 pending before the board of Justice Sudershan Kumar Misra shall stand transferred to the board of Justice Rajiv Sahai Endlaw.
7. Fresh Civil Writ Petitions (Service & Labour) shall be equally distributed between the roster benches of Justice Rekha Sharma and Justice Rajiv Sahai Endlaw on random basis.
8. Hon'ble Judge In-charge, Original Side will equally distribute arbitration matters to the two arbitration Courts and other matters to the remaining Courts.
9. Bail Applications, Criminal Appeals (SB), Criminal Misc. Main Cases, Criminal Revision Petitions (of the year 2011) pending before the board of Justice Hima Kohli shall stand transferred to the board of Justice V.K. Shali.
10. Criminal Writs of the year 2010 pending before the board of Justice A.K. Pathak shall stand transferred to the board of Justice Mukta Gupta.
11. Criminal Writs of the year 2011 pending before the board of Justice Hima Kohli, Justice Ajit Bharihoke, and Justice A.K. Pathak shall stand transferred to the board of Justice Mukta Gupta.
