1. Mentioning of urgent matters before DB-II.
2. Land Acquisition Appeals of other Districts (Central, North, South-West, East, North-East and New Delhi) shall be listed before Hon'ble Ms. Justice Hima Kohli pending as on 04.07.2011. Fresh Land Acquisition Appeals filed from 4<sup>th</sup> July, 2011 onwards shall be listed before Hon'ble Ms. Justice Hima Kohli.
3. Matters other than part-heard, presently pending before various Benches shall stand transferred to the respective Benches as per the above roster.
4. Specially directed matters may be assigned by Hon'ble the Acting Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or in specially constituted Benches.
5. Regular/final hearing matters would be listed chronologically so that old matters can be given priority in disposal.
6. Matters pertaining to unauthorized construction which were being listed before the Division Bench headed by Hon'ble Mr. Justice Vikramajit Sen shall be listed before Division Bench headed by Hon'ble the Acting Chief Justice.
7. All the Criminal Revisions, Criminal Writs and Criminal Miscellaneous cases pending on the board of Hon'ble Mr. Justice Ajit Bharihoke and Hon'ble Mr. Justice Suresh Kait, and one-half of the oldest cases on the board of Hon'ble Ms. Justice Mukta Gupta and Hon'ble Mr. Justice V.K. 10. Fresh Bail Applications shall be equally distributed amongst the roster benches of Hon'ble Mr. Justice V.K. Shali, Hon'ble Mr. Justice Ajit Bharihoke and Hon'ble Ms. Justice Mukta Gupta on random basis.
